

AN ORDER BY THE BOARD OF DIRECTORS OF KINGSLAND MUNICIPAL UTILITY DISTRICT CANVASSING AND DECLARING THE RESULTS OF THE GENERAL ELECTION HELD WITHIN THE DISTRICT ON MAY 4, 2024, AND CONTAINING PROVISIONS NECESSARY AND INCIDENTAL TO THE PURPOSE HEREOF

WHEREAS, this Board of Directors duly ordered a general election to be held for and within Kingsland Municipal Utility District (the "District") on May 4, 2024, for the purpose of electing Directors of the District for Director Places 1 and 2.

WHEREAS, this Board of Directors has investigated all matters pertaining to said election; and

WHEREAS, the election officers who held said election have duly made the returns of the results thereof, and said returns have been duly delivered to this Board of Directors; Now, Therefore

BE IT ORDERED BY THE BOARD OF DIRECTORS OF KINGSLAND MUNICIPAL UTILITY DISTRICT:

Section 1. Findings.

It is officially found and determined that said election was duly and lawfully ordered, that proper notice thereof was duly given, that proper officers were duly appointed prior to said election, that said election was duly and lawfully held and conducted, that only resident qualified electors of the District were permitted to vote in said election, that due returns of the results thereof have been made and delivered, and that this Board of Directors has duly canvassed said returns, all in accordance with applicable law and the order calling said election.

Section 2. Votes Cast.


It is hereby found and determined that the candidates for each Director Place in said election received the following number of votes:

Place No. 1:	Josh Caropepe	<u>90</u>	Votes
	Lewis Young	<u>41</u>	Votes
	David Travers	<u>63</u>	Votes
Place No. 2:	Dianne Wolfington	<u>166</u>	Votes

Section 3. Directors Elected; Resolution of Tie Vote.

As the result of said election, and in conformity with law, the candidate shown above as having received the greatest number of votes at said election for each such Place, each of whom is hereby found and determined to be qualified to serve as a director of the District, and not otherwise disqualified, is hereby declared elected a Director of the District in such place, subject to taking the oaths and otherwise qualifying as provided by law; provided that if two or more candidates for any Director Place shall be shown to have tied for the number of votes required to be elected, then the tie shall be resolved in the manner provided by law, including, particularly, Section 2.002 of the Texas Election Code, as amended.




